**WHEREAS**, the Commission on Filipinos Overseas (CFO) posted a Request for Quotation (RFQ) for the Procurement of Supply and Delivery of Seventeen (17) Units Small/Portable Air Purifier at the PhilGEPS website ([www.philgeps.gov.ph](http://www.philgeps.gov.ph)) on October 21, 2021 (RFQ No. 2021-10-042);

**WHEREAS**, in response with the said posting, three (3) suppliers – HYGIEIA INNOVATIONS AND TECHNOLOGY INC. (HYGIEIA), PACIFIC OFFICE SOLUTIONS, INC. (PACIFIC), and INHAIL TRADING (INHAIL) – participated in the said procurement activity;

**WHEREAS**, the above-mentioned suppliers submitted their respective quotations along with their BIR Form 2303, Latest Mayor's Permits, PhilGEPS Registration Numbers, SEC/DTI Certificate within the deadline as posted (1:00 pm, October 28, 2021) and passed the preliminary evaluation;
