WHEREAS, the Commission on Filipinos Overseas posted a Request for Quotation (RFQ) for the supply, delivery and printing of Primer under RA 9208 as amended by RA 10364;

WHEREAS, in response with the said posting, eight (8) suppliers expressed their interest to participate in the supply, delivery and printing of Primer under RA 9208 as amended by RA 10364;

WHEREAS, the suppliers are the following: VJ GRAPHICS ARTS, INC., GILCOR PRINTING PRESS, DEPENDABLE PACKAGING & PRINTING HOUSE CORP., INNOVATION PRINTSHOPPE, INC., BOOM PRINTS ENTERPRISES, AG3 COLORS PRINTING PRESS, KING PHIL PRINTING SERVICES AND COVER & PAGES CORPORATION;

WHEREAS, the above mentioned suppliers submitted their bids within the deadline as posted (1:00 pm, January 19, 2021), were found to be eligible, qualified and have passed the preliminary examination as shown in the table below;

DEPENDABLE PACKAGING & PRINTING HOUSE CORP., were which samples counter checked, verified and approved by the end users;

WHEREAS, after careful evaluation of the Bid Proposal and samples of the aforesaid suppliers submitted to the BAC and its Technical Working Group, the latter found **VJ GRAPHIC ARTS, INC.** to have passed the criteria for post-qualification and responsive to all the requirements and conditions for technical specification as specified in the bidding documents;

WHEREAS, the bid submitted by **VJ GRAPHIC ARTS, INC.** with a total amount of **One Hundred Four Thousand Pesos Only (Php 104,000.00)** was found and agreed by the BAC to be the most advantageous amount for the Commission on Filipinos Overseas;

NOW, THEREFORE, We, the Members of the CFO Bids and Awards Committee, hereby **RESOLVED** as it is hereby **RESOLVED** pursuant to Section 12 of R.A. No. 9184 and the applicable provision of its IRR, to declare **VJ GRAPHIC ARTS, INC** as the lowest calculated bidder and recommends the award of the contract to the latter for the supply, delivery and printing of Primer under RA 9208 as Amended by RA 10364.
