RECOMMENDING CANCELLATION OF CONTRACT WITH VJ GRAPHIC ARTS INC. AND RECOMMENDING THE AWARD FOR THE SUPPLY, DELIVERY AND PRINTING OF PRIMER ON R.A. 9208 AS AMENDED BY R.A. 10364 TO THE SECOND LOWEST CALCULATED BIDDER-GILCOR PRINTING PRESS

WHEREAS, the Commission on Filipinos Overseas (CFO) awarded the "Supply Delivery and Printing of Primer on R.A 9208 as amended by R.A. 10364" amounting PHP 104,000.00 to VJ GRAPHIC ARTS INC. with reference to Purchase Order 2021-01-002 dated <u>21 January 2021</u>;

WHEREAS, it is stated on the Request for Quotation No. 2021-01-001 under specifications that the primer will have 50 pages excluding covers. However, the final layout from the end-user contains 64 pages;

WHEREAS, VJ GRAPHIC ARTS INC. (VJ GRAPHIC) informed Mr. Arnel Sual through an e-mail dated February 01, 2021 that they have to change their quotation due to the additional pages. In lieu of this, VJ GRAPHIC submitted its new quotation amounting to Php 138,750.00 which exceeded the Approved Budget of the Contract (ABC).

WHEREAS, on February 02, 2021 GILCOR PRINTING PRESS (GILCOR), the Second Lowest Calculated Bidder was informed about the additional pages of the primer and GILCOR agreed to retain the amount on their quotation;

WHEREAS, during a meeting dated February 08, 2021, the Bids and Awards Committee (BAC) decided to cancel the contract with VJ GRAPHIC since said supplier can't comply with the new technical specifications without increasing its bid offer. The CFO BAC found and agreed that awarding the contract to the Second Lowest Calculated Bidder – GILCOR will be most advantageous for the Commission on Filipinos Overseas;

NOW, THEREFORE, WE, the Members of the CFO BAC, hereby recommend the cancellation of contract with **VJ GRAPHIC ARTS INC.** amounting to PHP 104,000.00 on the basis that the supplier can't comply with the new technical specifications of the contract without increasing its bid offer. The CFO BAC further recommend that the contract for the Supply, Delivery and Printing of Primer on R.A 9208 as amended by R.A. 10364 be awarded to the Second Lowest Calculated Bidder- **GILCOR PRINTING PRESS.**
