WHEREAS, the Commission on Filipinos Overseas (CFO) posted a Request for Quotation (RFQ) for the Procurement of Training Service Provider for the Webinar of Customer Service in the New Normal at the PhilGEPS website (www.philgeps.gov.ph) on November 02, 2021 (RFQ No. 2021-11-043);
