WHEREAS, the Commission on Filipinos Overseas (CFO) posted a Request for Quotation (RFQ) for the Procurement of Supply and Delivery of One (1) unit ID Maker at the PhilGEPS website (www.philgeps.gov.ph) and CFO Website on August 12, 2021 (RFQ No. 2021-08-034);

WHEREAS, in response with the said posting, four (4) suppliers – AZITSOROG, INC. (AZITSOROG), COMPETITIVE CARD SOLUTIONS PHILS. INC. (CCSPI), ALLCARD INC. (ALLCARD), PHILCOPY CORPORATION (PHILCOPY) – participated in the said procurement activity;

WHEREAS, the above-mentioned suppliers submitted their sealed quotations along with their BIR Form 2303, Latest Mayor's Permit, PhilGEPS Registration, and SEC Registration Certificate within the deadline as posted (1:00 pm, August 18, 2021) and passed the preliminary evaluation;




