**WHEREAS**, the Commission on Filipinos Overseas (CFO) posted a Request for Quotation (RFQ) for the Two (2) Lots Procurement of Supply, Delivery, Installation and Testing of CCTV System at the PhilGEPS website ([www.philgeps.gov.ph](http://www.philgeps.gov.ph)) and CFO Website on September 16, 2021 (RFQ No. 2021-09-038);

**WHEREAS**, in response with the said posting, two (2) suppliers – 7S CCTV SECURITY SYSTEMS CORPORATION (7S CCTV) and PRONET SYSTEMS INTEGRATED NETWORK SOLUTIONS INC. (PRONET)– participated in the said procurement activity;

**WHEREAS**, the above-mentioned supplier submitted their sealed quotation along with their BIR Form 2303, Latest Mayor's Permit, PhilGEPS Registration, and SEC Registration Certificate within the deadline as posted (1:00 pm, September 23, 2021) and passed the preliminary evaluation;

**WHEREAS**, the bid submitted by **PRONET for Lot 2: Supply, Delivery, Installation and Testing of IP Based CCTV System** with a total amount **Two Hundred Thirty Seven Thousand Six Hundred Thirty One Pesos and Nine Centavos Only (₱237,631.09)** was found and agreed by the BAC to be the most advantageous amount for the CFO.

**NOW, THEREFORE**, We, the Members of the CFO Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED pursuant to Section 12 of R.A. No. 9184 and the applicable provision of its IRR, to declare **PRONET SYSTEMS INTEGRATED NETWORK SOLUTIONS INC.** as the Lowest Calculated Responsive Bidder for the Procurement of Lot 2: Supply, Delivery, Installation and Testing of IP Based CCTV System. We further recommend the award of the contract to said supplier for the stated item.


