RESOLUTION DECLARING FILCRAFTERS INCORPORATED AS RESPONSIVE BIDDER AND RECOMMENDING FOR ITS AWARD THE PROCUREMENT OF SUPPLY, DELIVERY AND INSTALLATION OF MODULAR LAMINATED GLASS PARTITION FOR 24 SEATS AS REQUESTED BY THE MANAGEMENT INFORMATION SYSTEMS DIVISION (MISD)

## RESOLUTION NO. 2021-11-075 Series 2021

WHEREAS, the Commission on Filipinos Overseas (CFO) posted a Request for Quotation (RFQ) for the Procurement of Supply Delivery and Printing of Ten Thousand (10,000) pieces 2022 CFO PESO SENSE Calendar at the PhilGEPS website (www.philgeps.gov.ph) on November 18, 2021 (RFQ No. 2021-11-045);

WHEREAS, in response with the said posting, three (3) suppliers – 5JM MODULAR PARTITION AND OFFICE FURNISHING (5JM), FILCRAFTERS INCORPORATED (FILCRAFTERS), and RGSA CARPETS AND INTERIOR PRODUCTS INC. (RGSA) – participated in the said procurement activity;

WHEREAS, the above-mentioned suppliers submitted their respective quotations along with their BIR Form 2303, Latest Mayor's Permits, PhilGEPS Registration Numbers, SEC/DTI Certificate within the deadline as posted (1:00 pm, November 24, 2021) and passed the preliminary evaluation;

WHEREAS, on December 9, the MISD through the BAC Secretariat requested a cost breakdown to the two lowest bidders – Filcrafters and RGSA in order to aid them and the Technical Working Group (TWG) in the post-qualification evaluation process;

WHEREAS, on December 13, 2021, Filcrafters submitted its cost breakdown;

WHEREAS, on December 14, 2021, RGSA submitted its work breakdown instead of a cost breakdown;

WHEREAS, after careful evaluation of the BAC, End-user and its TWG the bid proposal of FILCRAFTERS INCORPORATED – second lowest bidder, passed the criteria for post-qualification and was responsive for CFO's technical specification requirement. Below table shows the result of the end-user and the TWG's evaluation:

WHEREAS, the bid submitted by FILCRAFTERS INCORPORATED for the requested item with a total amount of Five Hundred Ninety Four Thousand Six Hundred Seventy Five 75/100 Pesos Only (₱594,675.75) was found and agreed by the BAC to be the most advantageous amount for the CFO;

**NOW, THEREFORE**, We, the Members of the CFO Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED pursuant to Section 12 of R.A. No. 9184 and the applicable provision of its IRR, to declare **FILCRAFTERS INCORPORATED** as the Lowest Calculated Responsive Bidder for the Procurement of Supply Delivery and Installation of Modular Glass Partition for 24 seats as requested by the MISD. We further recommend the award of the contract to said supplier for the stated items.
