## RESOLUTION NO. 2022-01-004 Series 2022

WHEREAS, the Commission on Filipinos Overseas (CFO) posted a Request for Quotation (RFQ) for the Procurement of Supply, Delivery and Fabrication of One Thousand (1,000) copies of Presidential Awards for Filipino Individuals and Organizations Overseas (PAFIOO) Polo Shirt on the PhilGEPS website (<a href="www.philgeps.gov.ph">www.philgeps.gov.ph</a>), CFO website (<a href="www.cfo.gov.ph">www.cfo.gov.ph</a>), and send out said RFQ to prospective bidders on December 23, 2021 (RFQ No. 2022-12-047);

**WHEREAS**, no bids were received on the day of the deadline for the said posting (December 29, 2021, 1:00 P.M.);

**WHEREAS**, upon evaluation of the end-user and the CFO BAC Secretariat as to why there were no bids received, it was discovered that the design for the sleeves was hard to be embroidered. Hence, the layout for the Polo Shirt was revised:

**WHEREAS**, the CFO posted a 2<sup>nd</sup> RFQ for the said procurement requirement on January 14, 2022 (RFQ No. 2022-01-001);

WHEREAS, in response with the said posting, two (2) suppliers – KING OF KINGS TRADING (KING OF KINGS) and KNIT & TUCK MERCHANDISING (KNIT & TUCK) participated on the said procurement activity;

WHEREAS, the above-mentioned suppliers submitted their respective quotations along with their BIR Form 2303, Latest Mayor's Permits, PhilGEPS Registration Numbers, SEC/DTI Certificate within the deadline as posted (1:00 pm, January 20, 2022) and passed the preliminary evaluation;

WHEREAS, after careful evaluation of the BAC, End-user and its TWG the bid proposal of KING OF KINGS TRADING passed the criteria for post-qualification and was responsive for CFO's technical specification requirement;

WHEREAS, the bid submitted by KING OF KINGS TRADING for said procurement requirement with a total amount of Three Hundred Twenty Eight Thousand Pesos Only (₱328,000.00) was found and agreed by the BAC to be the most advantageous amount for the CFO;



NOW, THEREFORE, We, the Members of the CFO Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED pursuant to Section 12 of R.A. No. 9184 and the applicable provision of its IRR, to declare KING OF KINGS TRADING as the Lowest Calculated Responsive Bidder for Supply, Delivery and Fabrication of One Thousand (1,000) copies of Presidential Awards for Filipino Individuals and Organizations Overseas (PAFIOO) Polo Shirt. We further recommend the award of the contract to said supplier for the stated items.
