WHEREAS, the Commission on Filipinos Overseas (CFO) posted a Request for Quotation (RFQ) for the Procurement of One (1) lot Lease of Venue for the Joint Awarding Ceremony of the Migration Advocacy and Media (MAM) Awards and Himigrasyon Song Writing Contest for 100 pax to be held on March 16, 2022 on the PhilGEPS website (www.philgeps.gov.ph), CFO website (www.cfo.gov.ph), and send out said RFQ to prospective bidders on January 27, 2022 (RFQ No. 2022-01-002);

WHEREAS, In response of the said posting, four (4) suppliers – THE MANILA HOTEL (MANILA HOTEL), PHILIPPINE INTERNATIONAL CONVENTION CENTER (PICC), CITY GARDEN GRAND HOTEL (CITY GARDEN), and IMAGINIMAGE CORPORATION (IMAGINIMAGE) participated on the said procurement activity;

City Garden Grand Hotel (Rosemary Ballroom)	₱220,000.00	<ul style="list-style-type: none"> • Although with a lower bid, the proposal of the supplier did not meet the standards and expectation of the end-user; and • Hidden charges and add-ons will be necessary which will entail an even higher cost.
ImaginImage Corporation	₱246,670.00	<ul style="list-style-type: none"> • While the proposal seems to be compliant with the specifications of the end-user, the supplier is an event management company which would require additional layer of coordination; and • Although with a lower bid, the exact venue was not specified in the proposal which is the primary concern of the end-user.


