WHEREAS, the Commission on Filipinos Overseas (CFO) posted a Request for Quotation (RFQ) for the Procurement of Lease of Venue with Food and Accommodation for the conduct of CFO Strategic Planning for F.Y. 2022 on the PhilGEPS website (www.philgeps.gov.ph), CFO website (www.cfo.gov.ph), and send out said RFQ to prospective bidders on March 25, 2022 (RFQ No. 2022-03-011);

WHEREAS, in response of the said posting, Two (02) suppliers – MARIVENT RESORT HOTEL INC. (LAS CASAS FILIPINAS DE ACUZAR) and RANCHO BERNARDO LUXURY VILLAS & RESORT (RANCHO BERNARDO) participated on the said procurement activity;

WHEREAS, MARIVENT RESORT HOTEL INC. (LAS CASAS FILIPINAS DE ACUZAR) submitted the following documents along with their sealed price quotation before the deadline of submission of sealed quotation (March 22, 2022, 1:00 P.M.);

- e) Notarized Omnibus Sworn Statement;

- g) Certification indicating that Las Casas Filipinas De Acuzar is managed and operated by Marivent Resort Hotel, Inc.

WHEREAS, after careful evaluation of the BAC, End-user and its TWG, the bid proposal of MARIVENT RESORT HOTEL INC. (LAS CASAS FILIPINAS DE ACUZAR) passed the criteria for post-qualification;
