**WHEREAS**, the Commission on Filipinos Overseas (CFO) posted a Request for Quotation (RFQ) for the Procurement of One (1) Year Subscription of Online Corporate and Enterprise Email, Workspace and Cloud Business Solution on the PhilGEPS website ([www.philgeps.gov.ph](http://www.philgeps.gov.ph)), CFO website ([www.cfo.gov.ph](http://www.cfo.gov.ph)), and send out said RFQ to prospective bidders on March 15, 2022 (RFQ No. 2022-03-007);

**WHEREAS**, in response of the said posting, one (01) supplier – Q SOFTWARE RESEARCH CORPORATION participated on the said procurement activity;

**WHEREAS**, after careful evaluation of the BAC, End-user and its TWG, the bid proposal of **Q SOFTWARE RESEARCH CORPORATION** passed the criteria for post-qualification;

**WHEREAS**, the bid submitted by **Q SOFTWARE RESEARCH CORPORATION** for the said procurement requirement with a total amount of **Five Hundred Sixty Five Thousand and Four Hundred Eighty Eight Pesos Only (Php 565,488.00)** was found and agreed by the BAC to be the most advantageous amount for the CFO;


