**WHEREAS**, the Commission on Filipinos Overseas (CFO) posted a Request for Quotation (RFQ) for the Procurement of Training Service Provider for the Conduct of the ISO: 9001: 2015 Quality Management System Online Training for Twenty (25) Participants on the PhilGEPS website ([www.philgeps.gov.ph](http://www.philgeps.gov.ph)), CFO website ([www.cfo.gov.ph](http://www.cfo.gov.ph)), and send out said RFQ to prospective bidders on February 24, 2022 (RFQ No. 2022-02-004);

**WHEREAS**, in response of the said posting, one (01) supplier – W3 SOLUTIONZ TRAINING AND ASSESMENT CENTER (W3 Solutionz) participated on the said procurement activity;

**WHEREAS**, after careful evaluation of the BAC, End-user and its TWG, the bid proposal of **W3-Solutionz** passed the criteria for post-qualification:

**WHEREAS**, the bid submitted by **W3- SOLUTIONZ TRAINING AND ASSESSMENT CENTER** for the said procurement requirement with a total amount of **One Hundred Forty Six Thousand Pesos Only (Php 146,000.00)** was found and agreed by the BAC to be the most advantageous amount for the CFO;
