WHEREAS, the Commission on Filipinos Overseas (CFO) posted a Request for Quotation (RFQ) for the Procurement of Supply, Delivery and Installation of One (1) Unit 2.0 HP Inverter Air conditioning Unit (Split Type) and Supply and Delivery of One (1) 1.5 HP Inverter Air-Conditioning Unit (Window Type) on the PhilGEPS website (www.philgeps.gov.ph), CFO website (www.cfo.gov.ph), and send out said RFQ to prospective bidders on March 30, 2022 (RFQ No. 2022-03-013);

WHEREAS, in response of the said posting, Two (02) suppliers – VISTAAIRE BUILDERS AND AIRCONDITIONING SALES AND SERVICES INC. (VISTAAIRE) and WEATHERTECH REFRIGERATION AND AIRCON CO. (WEATHERTECH) participated on the said procurement activity;

WHEREAS, VISTAAIRE submitted the following documents along with their sealed price quotation before the deadline of submission of sealed quotation (April 05, 2022, 1:00 P.M.);

- a) PHILGEPS Platinum Membership Certificate (Valid until February 28, 2023);
- b) Mayor's/Business Permit (Valid until February 03, 2023);
- c) BIR Form 2303 Certificate;
- d) SEC Certificate:
- e) Notarized Omnibus Sworn Statement; and
- f) Product Brochure

WHEREAS, WEATHERTECH submitted the following documents along with their sealed price quotation before the deadline of submission of sealed quotation (April 05, 2022, 1:00 P.M.);

- a) PHILGEPS Platinum Membership Certificate (Expired, valid until February 17, 2022 only);
- b) Mayor's/Business Permit (Expired, valid until December 31,2020 only);
- c) BIR Form 2303 Certificate:
- d) SEC Certificate;
- e) Omnibus Sworn Statement (Not notarized); and
- f) Product Brochure

WHEREAS, after careful evaluation of the BAC, End-user and its TWG, the bid proposal of VISTAAIRE passed the criteria for post-qualification. The bid proposal of WEATHERTECH was found to be non-compliant on CFO's requirements and some of WEATHERTECH's documents were already expired;



WHEREAS, the bid submitted by VISTAAIRE BUILDERS AND AIRCONDITIONING SALES AND SERVICES for the said procurement requirement with a total amount of Ninety Seven Thousand Five Hundred Pesos Only (PhP 97,500.00) was found and agreed by the BAC to be the most advantageous amount for the CFO;

NOW, THEREFORE, We, the Members of the CFO Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED pursuant to Section 12 of R.A. No. 9184 and the applicable provision of its IRR, to declare VISTAAIRE BUILDERS AND AIRCONDITIONING SALES AND SERVICES as the Lowest Calculated and Responsive Bidder for the Procurement of Supply, Delivery and Installation of One (1) Unit 2.0 HP Inverter Air conditioning Unit (Split Type) and Supply and Delivery of One (1) 1.5 HP Inverter Air-Conditioning Unit (Window Type). We further recommend the award of the contract to said supplier.
