WHEREAS, the Commission on Filipinos Overseas (CFO) posted a Request for Quotation (RFQ) for the Procurement of Vehicle Rental for the CFO Team Building For 2022 on the PhilGEPS website (www.cfo.gov.ph), and send out said RFQ to prospective bidders on April 20, 2022 (RFQ No. 2022-04-014);

WHEREAS, in response of the said posting, One (01) supplier – KING'S COACH TOURS AND TRANSPORT CORP. (KING'S COACH) participated on the said procurement activity;

WHEREAS, KING'S COACH submitted the following documents along with their sealed price quotation before the deadline of submission of sealed quotation (April 26, 2022, 1:00 P.M.);

- a) PHILGEPS Platinum Membership Certificate (Valid until February 05, 2021);
- b) Mayor's/Business Permit (Valid until December 31, 2022);
- c) BIR Form 2303 Certificate;
- d) SEC Certificate:
- e) Accreditation as Tourist Land Transport Operator given by Department of Tourism;
- f) Certificate of Registration of three 2019 model buses; and
- g) Notarized Omnibus Sworn Statement;

WHEREAS, after careful evaluation of the BAC, End-user and its TWG, the bid proposal of KING'S COACH passed the criteria for post-qualification;

WHEREAS, the bid submitted by KING'S COACH for the said procurement requirement with a total amount of One Hundred Eighty Nine Thousand Pesos Only (PhP 189,000.00) was found and agreed by the BAC to be the most advantageous amount for the CFO;

NOW, THEREFORE, We, the Members of the CFO Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED pursuant to Section 12 of R.A. No. 9184 and the applicable provision of its IRR, to declare KING'S **COACH TOURS AND TRANSPORT CORP.** as the Sole Bidder for the Procurement Vehicle Rental for the CFO Team Building for 2022. We further recommend the award of the contract to said supplier.
