WHEREAS, the Commission on Filipinos Overseas (CFO) posted a Request for Quotation (RFQ) for the Lease of Hotel Venue with Banquet Service for the conduct of the Presidential Awards for Filipino Individuals and Organizations Overseas (PAFIOO) Awarding Ceremony and Testimonial Dinner on the PhilGEPS website (www.philgeps.gov.ph), CFO website (www.cfo.gov.ph), and send out said RFQ to prospective bidders on 16 June, 2022 (RFQ No. 2022-06-027);

WHEREAS, in response of the said posting, Two (02) suppliers – MARIOTT HOTEL MANILA (TRAVELLERS INTERNATIONAL HOTEL GROUP INC.) and THE MANILA HOTEL participated on the said procurement activity;

WHEREAS, MARIOTT HOTEL submitted their sealed quotation along with the following documentary requirements before the deadline of submission (June 20, 2022, 02:00 P.M.):

- PhilGEPS Certificate Platinum Membership (Valid until 24 February 2023);
- Mayor's/Business Permit (Valid until 31, December 2022);
- BIR Form 2303:
- SEC Certificate;
- Annual Income Tax Return for FY 2021; and
- Notarized Omnibus Sworn Statement

WHEREAS, despite submitting two sealed envelopes (one original and one photocopy) containing the documentary requirements, THE MANILA HOTEL did not include their quote/bid offer on the said envelopes making them ineligible to bid for the procurement requirement;

WHEREAS, after careful evaluation of the BAC, End-user and its TWG, Mariott Hotel Manila submitted the single calculated bid and passed the criteria for post-qualification;

WHEREAS, the bid submitted by Mariott Hotel Manila for the said procurement requirement with a total amount of Nine Hundred Sixty Thousand Pesos Only (PhP 960,000.00) was found and agreed by the BAC to be the most advantageous amount for the CFO;



**NOW, THEREFORE**, We, the Members of the CFO Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED pursuant to Section 12 of R.A. No. 9184 and the applicable provision of its IRR, to declare **MARIOTT HOTEL MANILA** as the Single Calculated and Responsive Bidder for the Lease of Hotel Venue with Banquet Service for the conduct of the Presidential Awards for Filipino Individuals and Organizations Overseas (PAFIOO) Awarding Ceremony and Testimonial Dinner. We further recommend the award of the contract to said supplier.
