## RESOLUTION DECLARING FIRST FAILURE OF BIDDING FOR THE PROCUREMENT OF TWO (02) MOTOR VEHICLES FOR THE COMMISISON ON FILIPINOS OVERSEAS

## RESOLUTION NO. 2023-05-023 Series 2023

WHEREAS, on 13 April 2023, an Invitation to Bid for the above stated project was posted at the PhilGEPS and CFO websites and sent out to prospective bidders;

WHEREAS, on 18 April 2023, a Pre-Bid Conference was conducted with one Prospective bidder – Mr. Edmon Telo of Mitsubishi San Pablo, Laguna, in attendance.

WHEREAS, two other bidders who were not able to attend the Pre-Bid Conference expressed their interest in participating in the said procurement activity;

WHEREAS, no bidder was able to avail of the official bidding documents and no bids were received on the scheduled deadline of submission of bids on May 11, 2023;

**WHEREAS**, on May 11, 2023, the CFO Bids and Awards Committee (CF)-BAC) declared a failure of bidding since no bids were received;

WHEREAS, in order to determine the reason for the failed bidding, the BAC revisited the technical specifications of the procurement requirement. In order to attract more bidders, the BAC decided to remove requirements that may not be applicable to some vehicles but the BAC retained engine displacement requirements approved by the Department of Budget and Management.

NOW, THEREFORE, we, the Members of the CFO-BAC hereby RESOLVE:

- 1. To declare the 1st FAILURE OF BIDDING for this project;
- 2. To recommend to the Head of the Procuring Entity (HoPE) the 1<sup>st</sup> FAILURE OF BIDDING and to RE-BID per Section 35 of the 2016 Revised IRR of RA 9184.
